

Help Central Colorado Conservancy Create the Ark River Community Preserve!

Protect the Lands and Waters that Sustain Us



Near Twin Lakes, Colorado, is a rare opportunity to preserve one of the last undeveloped stretches of private property along the Arkansas River—protecting key wildlife habitat and opening a mile of river to public access.

This pristine area, now up for sale, is a prime spot for development. Yet we have an opportunity with the Ark River Community Preserve to protect this special place and welcome community members and visitors to fish in Gold Medal Trout Waters. To raft and kayak the sparkling riffles. To hike or bike or ride horseback on the future Arkansas River Stage & Rail Trail. To watch the river's morning mists from the Highway 24 scenic byway.

Former wildlife biologist and Chaffee County resident John Andrick owns and loves the surrounding canyon—90 acres of land. He has offered to sell it to the Conservancy so that it can be preserved forever. So that the bighorn and elk, the bears and bobcat and bald eagles, can continue to call it home. So that future generations can enjoy this land and water even more than we do today.

In only one year, the Conservancy has secured most of the \$1.1 million total costs needed to buy and manage the property, through generous grants. **Now, we are working to raise the final \$50,000 to complete the purchase and create the Ark River Community Preserve.**

What the Preserve Would Do:

The proposed preserve would protect a mile of the Arkansas River, providing new public access to the river and to adjacent public lands.

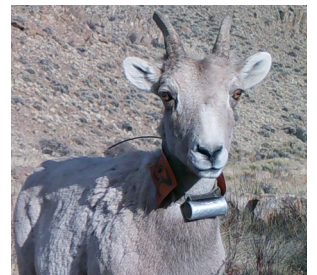
The property would be open to the public, through a partnership with the Arkansas Headwaters Recreation Area.

Where the Property Is Located:

One mile of the Arkansas River and shoreline north of Granite, where Highway 82 turns to Twin Lakes.

Who Will Benefit:

- **Wildlife** including bighorn sheep, elk, moose, mule deer, black bear, bobcat, mountain lion, and more whose lives depend on this habitat, wintering ground, and wildlife corridor.
- **Float and wader fishermen**, who gain a mile of permanent access to Gold Medal Trout Waters.
- **Bald eagles, ospreys, and red-tailed hawks** who hunt this stretch to feed their young.
- **Visitors** to the Top of the Rockies National Scenic Byway.
